SFI Tanzania is proud to be part of reestablishing Tanga region as a world class sisal producer by donating a total of **877,800** sisal suckers to sisal out growers and institutions during Q1. This will result in 527ha single row planting or 263ha double row planting for the outgrowers. On the right is a list of villages and institutions that received sisal suckers and the number donated.

#### Social

SFI Tanzania promotes health and safety of its employees and implementing OSHA principles in safeguarding the environment. Training is conducted annually to employees and surrounding communities regarding hygiene, fire safety, rights of communities through social monitoring. The company continues to build new houses and renovate high-risk structures. During Q1 SFI Tanzania completed 2 new houses, renovated 1 house, conducted 4 small renovations and demolished 2 high risk houses.

#### Environment

SFI Tanzania conducts annual water testing, fumigation of water bodies to curb malaria infections as well as Annual Environmental Auditing for forestry and sisal. The company continues to promote environmental awareness through training and the management of a zero-hunting policy on the estates. Indigenous trees are protected on SFI Tanzania estates. This allows species such as Colobus monkeys to be protected.
