SFI Tanzania is proud to be part of re-establishing Tanga region as a world class sisal producer.

During 2022 SFI Tanzania donated a total of 1,305,800

sisal suckers to sisal outgrowers that will result in 392 ha single row or 196 ha double row sisal plantings

2 Teak Outgrowers joined the SFI Tanzania teak outgrower program during 2022. This is due to lack of rainfall during the year. SFI Tanzania currently manages 164 teak outgrowers.

15 Intercropping Farmers joined the SFI Tanzania intercropping project during 2022.

26 SFI Tanzania employees benefitted from training during Q4. SFI Tanzania was pleased to welcome Tanga Regional Doctors Office who conducted First Aid and Emergency Response training to Dispensary Personnel. The SFI Safety Supervisor attended NOSHC training conducted by OSHA in Arusha. During 2022 a total of 944 employees benefitted from training.

Renovations

During 2022 SFI Tanzania built 3 new homes, renovated 3, demolished 4 and conducted small renovations to 14 other homes. Additionally, the Ruvu pump was fenced to increase security and the butchery was renovated in accordance with hygiene standards. Social

SFI Tanzania promotes health and safety of its employees and implementing OSHA principles in safeguarding the environment. Training is conducted annually to employees and surrounding communities regarding hygiene, fire safety, rights of communities through social monitoring. The company continues to build new houses and renovate high-risk structures.

Environmental Compliance

SFI Tanzania conducts annual water testing, fumigation of water bodies to curb malaria infections as well as Annual Environmental Auditing for forestry and sisal. The company continues to promote environmental awareness through training and the management of a zero-hunting policy on the estates. Indigenous trees are protected on SFI Tanzania estates. This allows species such as Colobus monkeys to be protected.
